Mary states that she often has to pick him up from school during the day because of illness and behavior problems. ES Form 4310 is completed by the child's doctor and it verifies the child's disabilities, and indicates that Mary is needed in the home to care for her child. There are no other caretakers able to provide this care. Mary would qualify for the caretaker hardship. 1b	Needed Caretaker 2 Parent household Hardship Met	John and Amy are married and have two school aged children. John is receiving SSI and Amy states she is needed in the home to care for him. Amy is given the ES 4310 to take to her doctor and when it is returned, it states that John needs full time care. The case manager and Amy discuss the possibility of having some outside help to care for John, so she is able to participate in the work program. Amy decides she is the caretaker for John. 1c	Needed Caretaker 1 Parent household Limited Hardship	Karen has 3 small children in the home. She states her oldest has medical issues and she needs to be at home to care for him. The medical form indicates this child has medical problems and Karen is needed in the home to care for him, but also indicates the situation can be controlled with medicine and surgery within 6 months. Karen is eligible for the caretaker hardship. In this situation, the hardship criteria is only valid for a limited time, and a Worker Alert (WOAL) is set for review of work participation at six months. Joyce is referred to an advocate to assist her in completing an application for Social Security. She keeps her appointments with the advocate. Joyce is eligible for the disability hardship criteria. At the six month review, the case manager contacts the Social Security Administration. Joyce's application was denied and she is past her date to appeal. If Joyce wants to be determined for Social Security benefits she will have to reapply. Contact with the Social Security advocate indicates Joyce has not responded to his letters or phone calls, and he was unable to file the appeal needed to keep the application current. It indicates Barbie's condition is not controllable with medicine or surgery within the next 12 months, however, it also does not indicate she needs full time care. Ken has no disabilities. Because all mandatory adults in the home are not disabled, this case does not meet any hardship criteria. Barbie's situation needs to be reviewed every six months to assure she continues to have a current social security claim on file, and a medical form is required annually. This is now a 1 Parent household. Ken is placed in an appropriate component. An IST is to be scheduled prior to the 60 th month of assistance. Missy does not meet the hardship criteria of Caretaker, and a staffing with the IST needs to occur if one has not already occurred and Missy needs to be placed in an appropriate work component. The case manager schedules a work program review with Tammy, as she is not putting in enough hours in her current assignment. The case manager explains she is over the 60 month time limit, and if she is to remain open, she will have to be involved in her work program thirty hours a week, as scheduled. At the end of the month, the work program provider notifies the case manager that Tammy has failed to complete the required 30 hours a week. Tammy's case is closed for non-cooperation with the work program, and Tammy would not be eligible for TAF at a later date unless she meets a hardship criteria.	PRAP is coded 60
