V058/ 058V	Simplified Reporter - and Cash	Notify food assistance of SR requirements and cash of CR requirements.
V059/ 059V	Simplified Reporter (IR) - and MS	Notify food assistance of SR requirements including IR and MS of CR requirements.
V060/ 060V	Simplified Reporter and SI	Notify food assistance of SR requirements and SI of CR requirements.
