### **NOTICE**

### **Proof of U.S. Citizenship Required for Voter Registration**

Any person registering to vote in Kansas for the first time is required to provide evidence of U.S. citizenship. If you do not provide a citizenship document when you complete your voter registration application, you must submit it to the county election office. You may submit it by mail, hand delivery, fax or email.

#### **Valid Citizenship Documents**

Here is a list of U.S. citizenship documents that are acceptable for voter registration:

- Birth certificate that verifies U.S. citizenship
- U.S. passport (may be expired)
- U.S. naturalization document or the number of the certificate of naturalization
- Bureau of Indian Affairs card number, tribal treaty number or tribal enrollment number
- U.S. hospital record of birth indicating place of birth in the U.S.
- U.S. military record of service showing applicant's place of birth in the U.S.
- Final adoption decree showing the applicant's name and U.S. birthplace
- U.S. citizenship document issued pursuant to the Immigration and Nationality Act of 1952
- Consular report of birth abroad of a U.S. citizen
- Certificate of citizenship issued by the U.S. Bureau of Citizenship and Immigration Services
- Certification of report of birth issued by the U.S. Department of State

### **La prueba de ciudadanía estadounidense esta requerido para el registro de votante**

Cualquier persona registrada para votar por primera vez en Kansas es requerida que proporcione evidencia de ciudadanía de los Estados Unidos. Si usted no proporciona un documento de ciudadanía cuando completa la aplicación para registrarse como votante, usted debe presentarla a la oficina de elecciones del condado. Usted lo puede presentar por correo, llevarlo en persona, fax o por correo electrónico.

#### **Documentos de ciudadanía validos**

La siguiente es una lista de documentos de ciudadanía que son aceptables para el registro de votante:

- Certificado de nacimiento que verifique ciudadanía estadounidense
- Pasaporte estadounidense (puede ser caducado)
- Documentos de la naturalización estadounidenses o el número del certificado de la naturalización
- Número de tarjeta de la Oficina de Asuntos Indígenas, número de tratado tribal o número de matriculación tribal
- Extracto de un hospital estadounidense de nacimiento que demuestre el lugar de nacimiento
- Documentos de servicio del ejército federal que demuestre el lugar de nacimiento
- Decreto de adopción final que demuestre el nombre y lugar de nacimiento estadounidense
- Documento de ciudadanía estadounidense dada según el Acto de la inmigración y la nacionalidad de 1952
- Anuncio consular de nacimiento de un/a ciudadano/a fuera de los EEUU
- Certificado de ciudadanía dada por los Servicios de Ciudadanía y la Inmigración Estadounidense
- La verificación de anuncio de nacimiento dada por el Departamento de Estado Estadounidense
