

RE Run Reason - Scenario 1 - LTC

April applies for HCBS for her 7-year-old daughter Rose. Rose is approved for HCBS (SED) coverage from 01/2022—12/2022.

Luke applies for himself and his wife Amanda. They are both approved for MDN coverage from 02/2022-01/2023 with a base period of 02/2022-07/2022. Workers determine Luke and his wife met their spenddown and a base period of 08/2022-01/2023 was established.

After the worker determines the spouse’s division of assets/allocation of income and adds an LTC record for Jose, **EDBC** must be run on the **LTC** program block first so allocations will correctly be determined. LTC applicants are processed on their own program block as a **Primary Applicant** which places the program block in pending status and the **EDBC Run Reason** is blank. Jose was approved for IC/NF/SN beginning 12/2022-11/2023.

RE Run Reason - Scenario 3b - E&D & LTC

Once EDBC has been Run, Accepted, and Saved for Jose, the worker will run EDBC for Maria on the MDN program block.

A worker picks up the task to add Jacob. When reviewing the case, the worker notes that it was *Discontinued* 11/2023 for *Failure to Return Review* and that Kimberly is currently in a *Reconsideration Period* ending 02/28/2024. Before adding Jacob, the Program must be reopened using Rescind without Review to process Jacob for MDN.

Rescind Without Review-Scenario 1b E&D

Because the application that was submitted only had information for Jacob, it cannot be used as a Review for Kimberly.
