

- d. The **Real Time Interface History Detail** page displays. The *Real Time Interface Request List* verifies the Request Status. The **Search Results Summary** displays if a response was received.

NOTE: The **Search Results Response** *Success* means a **Wage** record was found within the past 3 years and an **Unemployment (UC)** record was found within the past year.



- i. The KDOL UC record will display the KDOL US Interface List. On the KDOL UC Interface List page clicking the Week hyperlink displays the KDOL UC Interface Detail page that displays additional information.
- ii. The KDOL Wages record will display on the KDOL Wages Interface List. On the KDOL Wages Interface List click the Quarter hyperlink to display the KDOL Wages Interface Detail page that displays additional information.

The Kansas Department of Labor (KDOL) interface does not populate any data collection or verify a pending income record.

A historic record of calls to the Kansas Department of Labor (KDOL) interface is kept on the Real Time Interface History for the past 3 years. KDOL Unemployment is retained for 1 year. KDOL Wages are retained for the past 5 quarters.


