# Voter Registration Terms



## **Voter Registration Preference Questions –**

Questions within the Self-Service Portal (SSP) or Paper Application that request if the Primary Applicant would like a Voter Registration Card.

**Voter Registration Cover Letter** – A form generated through KEES explaining the reason for receiving the Voter Registration Application. There are two forms for this; one for DCF (V779), one for KDHE (V778).

**Voter Registration Card** –An enclosure added to the envelope with the Voter Registration Cover Letter. The Voter Registration Card is housed in the database, but not generated by KEES Doc Parameters or KEES Batches.

# Voter Registration Changes

## Both SSP & Paper Application Processes

Consumers will be asked about **Voter Registration** preferences for Medical, Non-Medical and LIEAP SSP applications.

**New!**

**Voter Registration** preference questions have been added to Paper Applications sent from KEES.

## Batch Process Automation

**Voter Registration** was a manual process for the Workers to perform.

**Better!**

Now, Workers can generate the **Voter Registration Cover Letter** through a KEES batch.

Then, at **Central Print**, the cover letter and registration card are combined in an envelope and mailed to the Consumer.

# Voter Registration Changes

## New

The new Medical and Non-Medical **Voter Registration Cover Letter** is tied to the distributed documents on the case it is sent for.

The **Voter Registration Cover Letter and Card** will be sent through a weekly batch printed and mailed from Central Print.

The new **Voter Registration Cover Letter** and **Voter Registration Card** can be generated in English or Spanish.

**Note:** The Voter Registration Cover Letter will not be sent to the Authorized Representative or additional correspondence recipients on the case.

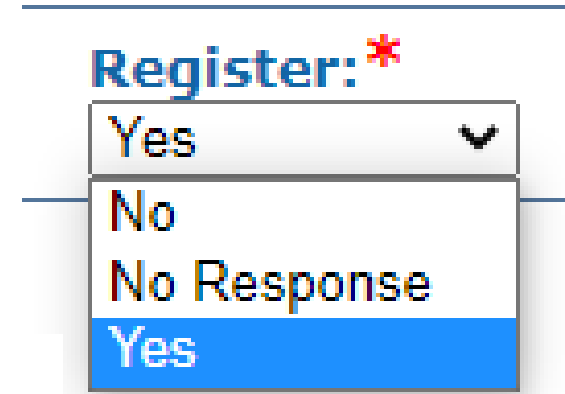

# When is “No Response” the appropriate response?

## Consumers

The Consumer was trying to answer all the  
\*Required questions and simply overlooked the Voter Registration question on the SSP or paper application. **KEES SSP completes the field as “No Response”.**

The Consumer doesn’t know if they are already a registered voter, so they do not provide a Yes or No response in the SSP application. **KEES SSP completes the field as “No Response”.**

The Consumer didn’t provide an answer on a paper application.

## Workers

The Worker is entering or processing an application and the Voter Registration choices are blank. The correct entry is then **No Response**.

A Worker is helping a Consumer and the Worker asks the Consumer, “Would you like to receive a Voter Registration form?” If the Consumer responds with anything other than a definitive Yes or No, the correct entry should be **“No Response”**.

**No Response** ensures the Consumer receives Voter Registration forms and information. Then, they can decide their Voter Registration needs in the privacy of their home.

## Physical Address Change

When a Consumer's physical address is changed, KEES will automatically submit the record to the Voter Registration batch.

If that Consumer has both Medical and Non-Medical cases, the physical address change will be reflected for both case types.

It does not matter whether the physical address is changed on a Medical or Non-Medical case, the **Voter Registration Cover Letter** form will be ***generated from the case with the most recent EDBC processed*** (based on logic programmed in the KEES change of address voter registration batch).

*The Policy is to send a **Voter Registration** form any time there is a Physical Address Change on **ACTIVE** non-PPS cases. Active is defined as Active Status in the month the Address record was added or modified.*

# Worker Generates a Voter Registration Application

## Print Locally

- From **Distributed Documents**, generate the **V778 Voter Registration Cover Letter** and **Save and Print Locally**.
- **Voter Registration Card** must be manually included in the envelope with the Voter Registration Cover Letter.
- Consumers who have opted-out of paper will receive electronic (PDF) copies of the **Voter Registration Cover Letter** and the **Voter Registration Application** through the Consumer's self-service portal **Message Center**.

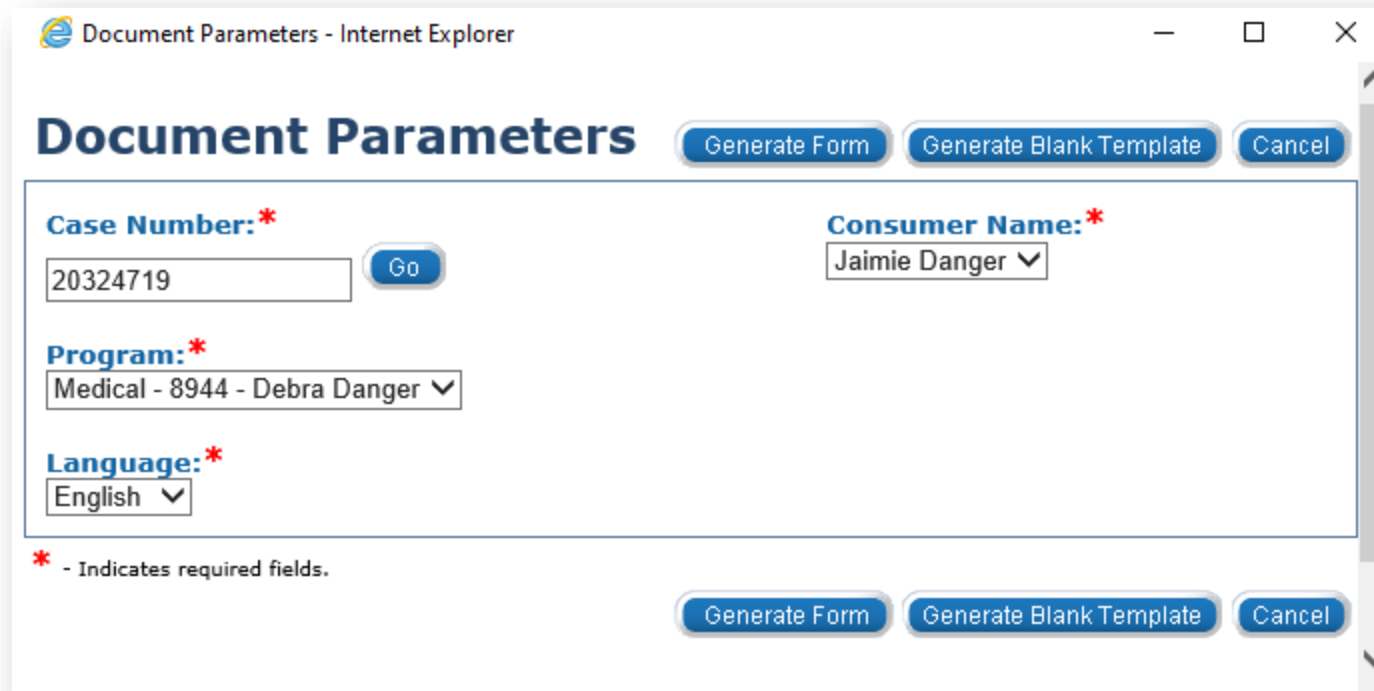
## Batch to Print Centrally

- From **Distributed Documents**, generate the **V778 Voter Registration Cover Letter** and **Save and Print Centrally**.
- **Central Print** encloses the **Voter Registration Card** with the **Voter Registration Cover Letter** and the envelope is mailed that night.
- Consumers who have opted-out of paper will receive electronic (PDF) copies of the **Voter Registration Cover Letter** and the **Voter Registration Application** through the Consumer's self-service portal **Message Center**.



# Can Other Household Members Over 18 Request Voter Registration?

If someone other than the Primary Applicant wants Voter Registration information, staff can generate the request(s) manually through Distributed Documents.

### You can use this application to:

- register to vote in Kansas
- change your name, address, or affiliation with a political party

### To register to vote, you must:

- be a U.S. citizen and a resident of the state of Kansas.
- have reached the age of 18 years before the next election.
- have received final discharge from imprisonment, parole, or conditional release if convicted of a felony.
- have abandoned your former residence and/or name.

### How to register to vote:

- Return your completed application to your county. Addresses are on the back of this application. Your county election officer will mail you a notice when your application has been processed.

- Voter registration closes 21 days before any election. In order to be eligible to vote in that election, your application must be postmarked on or before that date.
- If you decline to register to vote, that fact will remain confidential and will be used for voter registration purposes only. If you do register to vote, the office where you apply will be kept confidential and will be used for voter registration purposes only.
- If this form is incomplete, it may be rejected.

### Identification number requirements

Enter your current Kansas driver's license number or nondriver's identification card number. If you do not have either one, enter the last four digits of your Social Security number. If you do not have any of these numbers, write "none" in the box. The number will be used for administrative purposes only and will not be disclosed to the public. K.S.A. 25-2309

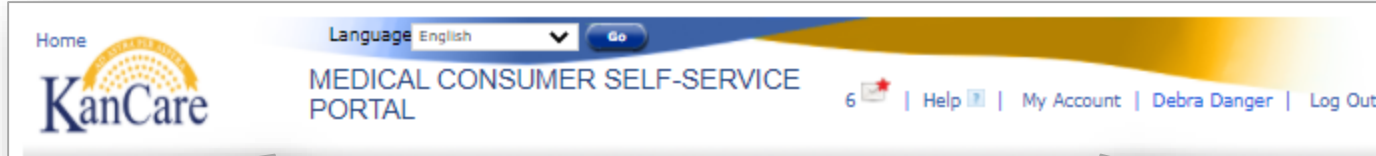

If you need additional voter registration forms or help filling one out, please call KanCare at 1-800-792-4884.

If you choose to register to vote at this time, you may either mail the completed form to your county election office (those addresses are provided with the voter registration form), mail it to KanCare, P.O. Box 3599, Topeka, KS, 66601, or deliver it to any of our Medicaid eligibility offices. If you deliver your completed form to KanCare, we will send it to your county election office. If you need help filling out or mailing this form, you can call our offices, or you can call the Secretary of State at 1-833-765-2003 for assistance. If you need interpretation assistance, call us at 1-800-792-4884 (TTY: 1-800-792-4292).

Voting is a great way for eligible Kansans to make their voices heard in our democracy. Your decision to register or not register to vote will not affect your benefits or the amount of assistance the agency will provide you.

You should only register to vote if you are a U.S. citizen who lives in Kansas, you are at least 18 years old or will be 18 years of age before the next election, and you are not currently in prison, on probation, or on parole for a felony conviction. If you have questions about your eligibility to register to vote, call the Secretary of State at 1-800-262-VOTE (8683). You must re-register each time you change your name, address, or party affiliation for voting, so you should re-register to vote if you have moved since the last time you voted. Please note that you will be required to show photo identification at the polls.

You may also choose to register to vote online by going to <https://www.kdor.ks.gov/apps/voterreg/default.aspx>. To register online, you must have a valid Kansas driver's license or state-issued identification card. If you do not have either of these documents, you may register to vote using the paper form provided in this mailing or you can download one at the following link if you have a printer: <https://www.kssos.org/forms/elections/voterregistration.pdf>.

If you believe that someone has interfered with your right to register or to decline to register to vote, your right to privacy in deciding whether to register or in applying to register to vote, or your right to choose your own political party or other political preference, you may file a complaint with the Kansas Secretary of State's Elections Division by calling 1-800-262-VOTE (8683) or sending an email to [election@ks.gov](mailto:election@ks.gov).
